SAİM KAYADİBİ, PROFESÖR DR, 1991-92 yılında Konya Merkez İmam Hatip Lisesi'nden mezun oldu. 1997 Yılında Mısır El-Ezher Üniversitesi Şeriat ve Kanun Fakültesi İslam Hukuku Bölümünde Lisans eğitimini tamamladı. 1998 yılında Ürdün Üniversitesi'nde İslam Hukuku dalında Yüksek Lisansına başladı. Daha sonra 1999'da İngiltere'ye eğitim için gitti. Newcastle College'da İngilizce dil eğitimine başladı. 2000 yılında Durham Üniversitesi Uluslararası İlişkiler ve Devlet Yönetimi Okulu'nda Ortadoğu ve İslam Araştırmaları Bölümünde Yüksek Lisansa başladı. 2006 yılında İngiltere Durham Üniversitesi'nde İslam Hukuku alanında Birleşik (M.Phil & PhD) Doktorasını tamamladı.

2008-2010 yılları arasında Malezya Malaya Üniversitesi (UM) Akademi Pengajian Islam, Syaria Undang Undang (Shariah and Law) fakültesinde Yardımcı Doçent olarak çalıştı. 2010-2011 Yılları arasında Malezya Uluslararası İslam Üniversitesi, İktisadi ve İdari Bilimler Fakültesi, Ekonomi bölümünde Yardımcı Doçent, yine aynı fakültenin Ekonomi bölümünde 2011-2019 yılları arasında Doçent olarak çalışmalarını sürdürdü.
